Quarterly Highlights:

SMHC:

With the success of presentations throughout Sanford School Department during this quarter, DTPP and Sanford Junior High School have scheduled vape-specific focus groups that will be occurring in February. Due to high interest in this topic by students and staff, these groups will continue the conversations detailed in the presentations. The groups will be led by DTPP and the school outreach worker, but will also allow students to have open discussions about topics of interest.

With the adoption of a worksite smoke-free policy at Nasson Community Center, the Director and DTPP have worked together to gather resources for staff and members, as well as the adjoining childcare center. Interest from the childcare center in smoke-free promotion then resulted in this YSE to also adopt a smoke-free policy.

DTPP has been an active member of five committees. Although work has been successful within all districts, the Sanford Drug-Free Communities Committee, as well as the DFC workgroup, have planned for two events. DTPP and the DFC members have worked with many school staff to prepare for a parent information session. This collaboration also resulted in the successful planning of an event with a guest speaker, which will highlight education and resiliency in March.
